Applicant Volume Up

As of 1/19/18, there are 191,998 applications submitted by 29,287 applicants for the 2018–2019 academic year. Applicants are up 9.5% and applications are up 10.6% from 2017–2018.

Annmarie Levins Joins LSAC Leadership Team

Annmarie Levins joined LSAC in December as Senior Vice President and Chief Strategy Officer. She will be working closely on business strategy with LSAC President and CEO Kellye Testy and the rest of LSAC's leadership team.

Annmarie is a cutting-edge thinker about the future of law and society. Her most recent work, at the Data & Society Research Institute in New York, focused on the impact of artificial intelligence and data analytics on the practice of law and the future of the legal profession. She studied how these technological advances can help address persistent inequalities in access to legal services.

According to Kellye Testy, "Annmarie's understanding of the ways technology can level the playing field for all who are seeking access to justice is essential as LSAC partners with its law school members and others to build the justice pipeline for the future. Annmarie's strong skills in organizational strategy and forging strong partnerships are exactly right for LSAC at this exciting time."

From her nearly two decades with Microsoft, Annmarie brings deep experience in law, management, and technology, as well as developing corporate and nonprofit strategic vision and implementation plans. She has served on the boards of a number of state and regional organizations. Early in her career, she clerked for the Honorable Lewis F. Powell at the Supreme Court, taught law at the University of Washington School of Law, and worked as an assistant US attorney for both the Southern District of New York and the Western District of Washington.

Annmarie earned her BA in political science at Brown, her PhD in politics at Princeton, and her JD at the University of Maine School of Law, where she was first in her class and editor of the *Maine Law Review*.

LSAC Adds Test Dates

LSAC is adding an additional US test date for the 2018–2019 year. This addition means the LSAT will be offered at least every other month for the convenience of prospective law students. Test dates are:

- June 11, 2018
- July 23, 2018
- September 8, 2018
- November 17, 2018
- January 26, 2019
- March 30, 2019
- June 3, 2019

The July 23 test will be given only in North America. LSAC expects to make further announcements regarding new delivery formats for the LSAT this spring.

Still Largely Without Power, Puerto Rico Gets Additional LSAT Date

While in San Diego for the AALS Annual Meeting in early January, Dean Vivian Neptune of the University of Puerto Rico School of Law caught up with LSAC staff members and requested the administration of an additional LSAT in March to help potential law students in Puerto Rico. The law school's application volume has been down due to the continued effects of Hurricane Maria. Many potential applicants have had no place to prepare for the LSAT due to lack of electricity, but that situation is supposed to be much improved by March.

In February 2017, 662 test takers took the LSAT in English in Puerto Rico, but at the time this article was written, only 212 people had registered for the February 2018 LSAT there. Registrations for the Spanish LSAT in Puerto Rico are at roughly the same level as last year. Therefore, LSAC will offer an additional administration of the LSAT in English at the Rio Piedras and Mayaguez test centers in Puerto Rico on Saturday, March 10, 2018. We are grateful to Dean Neptune for bringing this situation to our attention.

LSAC and AALS Partner on Projects Supporting Legal Education and the Rule of Law

On January 5, Kellye Testy announced a new partnership between LSAC and AALS for the development of several projects that will benefit prospective law students, law schools, and the rule of law. The projects include an integrated digital strategy for better communicating with prospective law students before and during college, when they may first be considering pursuing an advanced degree. The two organizations will also work together to enhance support for prelaw advisors at colleges and universities around the United States as part of a project aimed at improving available resources for prelaw advisors and their students.

"By linking our outreach to candidates and prelaw advisors more directly with AALS's strong engagement with the faculty and programs at member schools, we will strengthen the justice pipeline at critical points," said Testy.

Judy Areen, the executive director of AALS, is equally enthusiastic about the partnership, noting that all involved in legal education can benefit from this innovative combination of talent and expertise from both organizations. "Through these efforts, prospective law students will have better access to information about legal education and the value of a law degree," Areen said.
