# **Introductory Notes**

• These data are displayed by Academic Year, which is the same as the law school enrollment year. For example, academic year 2017 or 2017-2018 would indicate the academic year beginning in the fall of 2017 and extending into spring 2018.

• The Current Volume data tables include applicants for all academic terms. Current Volume reports published before 2017 summarized applicants for the fall term only and are not comparable to these new volume reports.

• ABA data reflect applicants and applications for ABA-approved law schools.

• Deferrals are not included in either the ABA or Canadian data. Deferrals are defined as "applicants admitted for a prior term who were granted a postponed enrollment to the current term."

- Please note as defined in this report, an applicant is a candidate who submits one or more applications for any academic term.
- The data for this report are updated every evening and will reflect current volumes as of that time.
- Data for the 2018-2019 academic year is not updated after 08/08/2018.
- Data for the 2019-2020 academic year will begin appearing in late November 2018.
