LSAC's LawReady is a bold undergraduate initiative designed to offer a new, holistic pathway to law school. LawReady helps students develop and demonstrate mastery of the skills necessary for success in law school. LawReady also provides a better understanding of the legal profession and law school experience, tools for mastering the application process, and strong support networks to help students throughout their legal education journeys. Building on LSAC's years of experience in supporting law schools and students with a range of assessment tools, educational resources, and candidate recruitment programs, LawReady will attract even more individuals to consider law and address many of the challenges and barriers that prospective students face.

Students who pursue LawReady will take academic courses aligned to the requisite skills and abilities for law school readiness which will count toward their major and graduation requirements. They will receive support for exploring different pathways to law and justice careers through internships, experiences, and activities, as well as support for applying to and preparing for law school. Students will develop a sense of belonging within the legal profession as they receive community support through study groups, mentors, and cohorts. The program will culminate with a portfolio of work and Legal Education Certificate that can be submitted to law schools to which students are applying.

While studies consistently show that the LSAT is the single best predictor of law school success and that the LSAT's predictive validity is consistent across all demographic groups, LSAC is innovating to create an additional pathway to law school that meets potential students earlier in their academic careers with a holistic approach to building the skills and support needed to help them define, pursue, and succeed in their educational goals.
