In the Law School Engagement area, there are three teams that work directly with law schools.

- ✓ The **LSAC Ambassadors** are law school admission experts. They travel to law schools to connect one-on-one with admission professionals, support their work, understand challenges, and recommend solutions using LSAC tools and resources.

The Ambassadors help admission offices build informative, effective recruiting and other events. They are pleased to staff tables to engage with prospective applicants and answer questions or share presentations on topics such as LSAC resources, LSAT prep, choosing the right law school, and more.

- ✓ **School Account Executives** provide non-technical assistance for issues related to the Online Admission Directory, the Official Guide, listservs, and more. They have answers to your questions about almost anything LSAC-related.
- ✓ **Events and Logistics team** members plan and execute all LSAC key learning and recruitment events, such as the LSAC Annual Meeting, Newcomers Workshop, LSAC Law School Forums, webinars, and more.
