This guide is intended to help you on your path to finding the law school that is right for you — one that meets your academic, personal, and professional needs and interests while supporting and encouraging you to thrive as your full authentic self, both inside and outside the classroom.

As you start to think about law school,

try to imagine your ideal learning environment. Think about how important you feel it is for you to be able to safely share your identity with peers and faculty — and to be surrounded by a community of other LGBTQ+ students.

LSAC's LGBTQ+ Guide to Law Schools will give you details on practices and policies at more than 100 law schools in the U.S. and Canada, so you can build your list and find a law school that meets your personal, academic, and professional needs.

Questions to ask law schools

Allow yourself plenty of time to meet law school representatives at events like the LSAC Law School Forums and to schedule in-person or virtual campus visits. Remember to ask questions! We've compiled the below lists of good questions to ask, in a few different categories, so you can get the answers you need — and decide on a law school that is right for you.

APPLICATION PROCESS

- How does the admissions office view coming out during the application process?
- Does the application offer inclusive gender options to choose from?
- Does the application ask about sexual orientation or gender identity? If so, how is this information used?
- How can I share my perspective and lived experience in the application?
- Can you connect me to an LGBTQ+ graduate or current student, so I can ask about their experience here?



TIP: If you are more comfortable asking personal questions via email, request to be put in contact with the appropriate person.

PERSONAL AND COMMUNITY

- How many LGBTQ+ students enroll each year?
- What LGBTQ+ student organizations exist at your school?
What kind of activities do they plan or are they involved in?
- Are there LGBTQ+-identifying faculty, staff, and administrators?
- How welcoming are the campus and surrounding area? Is there anything I should know about the state or region that could impact my experience or safety?
- Are there all-gender restrooms available? Are they ADA accessible?
- Is there campus family housing available, and are same-sex families eligible? Are related housing policies inclusive of nonbinary individuals?
- How does the school recognize events such as Pride Month, Trans Day of Visibility, etc.?
- If issues arise, who would I talk to, and how would I seek support from the school's administration?
- Can my chosen name/name in use appear in campus systems (e.g., class rosters, student ID cards, diplomas, etc.)?
- Does your school provide healthcare coverage? If so, does this coverage include gender-affirming medical treatments?
- Are there physical spaces for queer students (e.g., an LGBTQ+ resource center, gathering places for clubs and organizations, etc.)?

ACADEMIC AND PROFESSIONAL

- Could you tell me about the classes you offer on issues affecting LGBTQ+ communities?
- Are LGBTQ+ issues/case law incorporated into the curriculum beyond specifically dedicated classes?
- Are there research centers, clinics, journals, or other opportunities where I can focus on LGBTQ+ topics?
- What kind of advising is available for LGBTQ+ students to help navigate the job search process?
- Is there an active LGBTQ+ alumni group?
- Does the school offer mentorship programs specifically for LGBTQ+ students?
- Does your school sponsor, promote, or connect students with the Lavender Law Conference?



After each meeting or visit, ask yourself:

- Was there a visible queer presence on campus?
- Do I feel like I could safely be my authentic self around students, faculty, and staff?
- Can I see myself thriving here?

As you apply and decide where to enroll, ask yourself:

- Does the application use gender-inclusive language?
- Do I feel seen when filling out the application?



Law schools differ in many ways,
and asking questions will help you
make an informed decision as to where
you want to continue your journey
in a way that is authentically yours.
