DRIVING INFORMATION

The Philadelphia Law Fair will be held at Behrakis Grand Hall, Creese Student Center, 32nd and Chestnut Streets, Philadelphia, PA 19104. This location is a 5-10 minute walk from Amtrak's 30th Street Station. Both Amtrak and SEPTA Regional Rail serve 30th Street Station, providing convenient access for those traveling from New York, Baltimore, and Washington, DC. Representatives arriving via air may take the SEPTA train directly from the Philadelphia International Airport to 30th Street Station. Taxi service is available for those who prefer it.

PARKING

If you decide to drive, you may park in one of several lots. Amtrak operates a parking garage at 30th Street Station. Commercial parking lots are located on both JFK Boulevard and Market Street, between 30th and 32nd Streets. The Drexel University parking garage is located at 34th and Ludlow Streets. Each of these facilities is a 5-10 minute walk from the Fair location.
