# **DRIVING INFORMATION**

The University of Puget Sound is located at 1500 North Warner Street in Tacoma, WA, approximately 30 miles south of Seattle and 15 miles north of Olympia. Driving to campus: From I-5, take exit 133, Interstate 705 north, City Center exit. Exit at Schuster Parkway. Continue for approximately one mile and stay to the left to continue on Schuster Parkway, following Schuster along the water. Stay to the right and exit onto North 30<sup>th</sup> Street. Continue through the traffic signal in Old Town and up the hill. From N. 30<sup>th</sup> street hill, turn left onto North Alder. Continue approximately one mile. The campus will be on your right. The Wheelock Center can be accessed from either N. 15<sup>th</sup> or N. 14<sup>th</sup> street. See information below on parking.

Free visitor parking lots can be accessed from N. 15<sup>th</sup> Street; Parking lot P6 (campus map) with accessible parking available in the lot on N. 14<sup>th</sup> St. (P1 campus Map).
