### PARKING

For prospective law fair attendees, there are several hourly visitor parking lots (designated by a green shield) on the DU campus. The cost for parking in a paid an hourly lot is \$2.00/hour with a maximum of \$10 for the day. Lots that are closest to the Sturm College of Law include:

- Lot 321 – Ricketson Law Building Hourly (the only way to access this garage is from the West bound lane of E. Evans Ave.)
- Lot 317 – Asbury Avenue Hourly
- Lot 301 – Evans Garage Hourly (on the corner of E. Evans Ave. and S. High St.)
