## DRIVING INFORMATION

Directions from I-35: Exit East on Main Street (Exit 109). Travel east on Main Street (approx. 1/3 mile) to 24<sup>th</sup> Ave. N.W. Turn south (or right) onto 24<sup>th</sup> Ave. N.W. Travel approx. ½ mile to Boyd Street. Turn east (or left) onto Boyd Street. Travel east on Boyd (approx. 2 miles) to Asp. Turn right onto Asp. The Union is the third building on your right.

## PARKING

*Recommended: If taking Uber, Lyft, or another ride sharing option, request drop off at 900 Asp Ave., Norman, OK, 73019. The Union is third building south of Boyd St. on the west side of Asp Ave.*

*If driving, plan to arrive early to allow time to find parking. Parking on campus is limited. The closest parking garage is connected to the Union, located at 900 Asp Ave. If the Union garage is full, the next two closest parking garages are the Asp Parking Facility, (located in area E7 on the campus map, link below), and the Elm Parking Facility (located in area B3 on the campus map, link below).*
