### **COVID Protocols:**

All DU visitors must fill out a “Visitor Screening Survey” prior to coming to campus. Before arrival, please fill out the Visitor Survey no more than 12 hours prior to arriving on campus: Visitors Survey. Additionally, DU has a vaccine and booster requirement for all faculty, students, and staff. As of now, there is not a mask mandate (for those who are fully vaccinated) in place on campus, though attendees are welcome to wear masks during the event and we will have extra on-hand. University policies may change as conditions change. Registered law schools will be notified as soon as possible of any changes that may impact how the event will be conducted.

### **LODGING**

## **TRANSPORTATION**

Transportation from Denver International Airport (DIA):

DIA is located on the outskirts of town, and there are several transportation options to get from DIA to your hotel.

*Airport Rail:* It's easy to get from [Denver International Airport \(DIA\)](#) to downtown Denver. At a cost of \$10.50 each way, travelers can take the [airport rail](#) from DIA to [Denver Union Station](#) and vice versa. It takes only 37 minutes.

*Uber/Lyft/Taxi:* Taxis and rideshare services are easily accessible at the airport. It is recommended that you check both Uber and Lyft when leaving the airport to see which option is cheaper. Typically, a ride from DIA to downtown is \$40+.

*Hotel Shuttle Bus:* Some local hotels offer their own shuttle service. Please check with your hotel.

*Rental Car:* The major rental car agencies have offices at the airport.

### **RTD Light Rail:**

The RTD Light Rail is a great way to get around Denver. This transportation option is convenient for going from the airport to downtown Denver and from downtown Denver to DU's campus.

The *RTD University Station* is a quick 10-minute walk from the Community Commons Building. Simply type into Google Maps the walking directions from: RTD University Station, 1881 Buchtel Blvd S, Denver, CO 80210 □ Community Commons, 2055 E Evans Ave, Denver, CO 80210.
