EVENT LOCATION

The event is located on the UNR campus on the 4th floor of the Joe Crowley Student Union (JCSU), commonly referred to as “the Joe”. The fourth floor has ballrooms, as well as a few meeting rooms that can be used for presentations, etc. The facility is often busy with students as it contains many student services, places to study, a bookstore, and food options, including Starbucks.

TRAVEL INFORMATION

Reno-Tahoe International Airport (RNO) is located about 5 miles from the university and is served by most domestic airlines. Taxis and rideshare services are easily accessible at the airport and some local hotels offer their own shuttle. Most major rental car companies also have counters at the airport with cars available on site.

PARKING

Parking will be available on the top floor of the West Stadium Parking Complex. Be sure to enter off of 16th Street for easiest access to the top floor. You can email jdeason@unr.edu after October 1 for the parking code, otherwise instructions will be emailed to all registered representatives the day before the fair. There is also a rideshare drop-off in front of the Lawlor Event Center (see map below).

If shipping materials ahead of time they **must** arrive by **Wednesday, October 21st**, for guaranteed on-time delivery for the fair. Please send materials to:

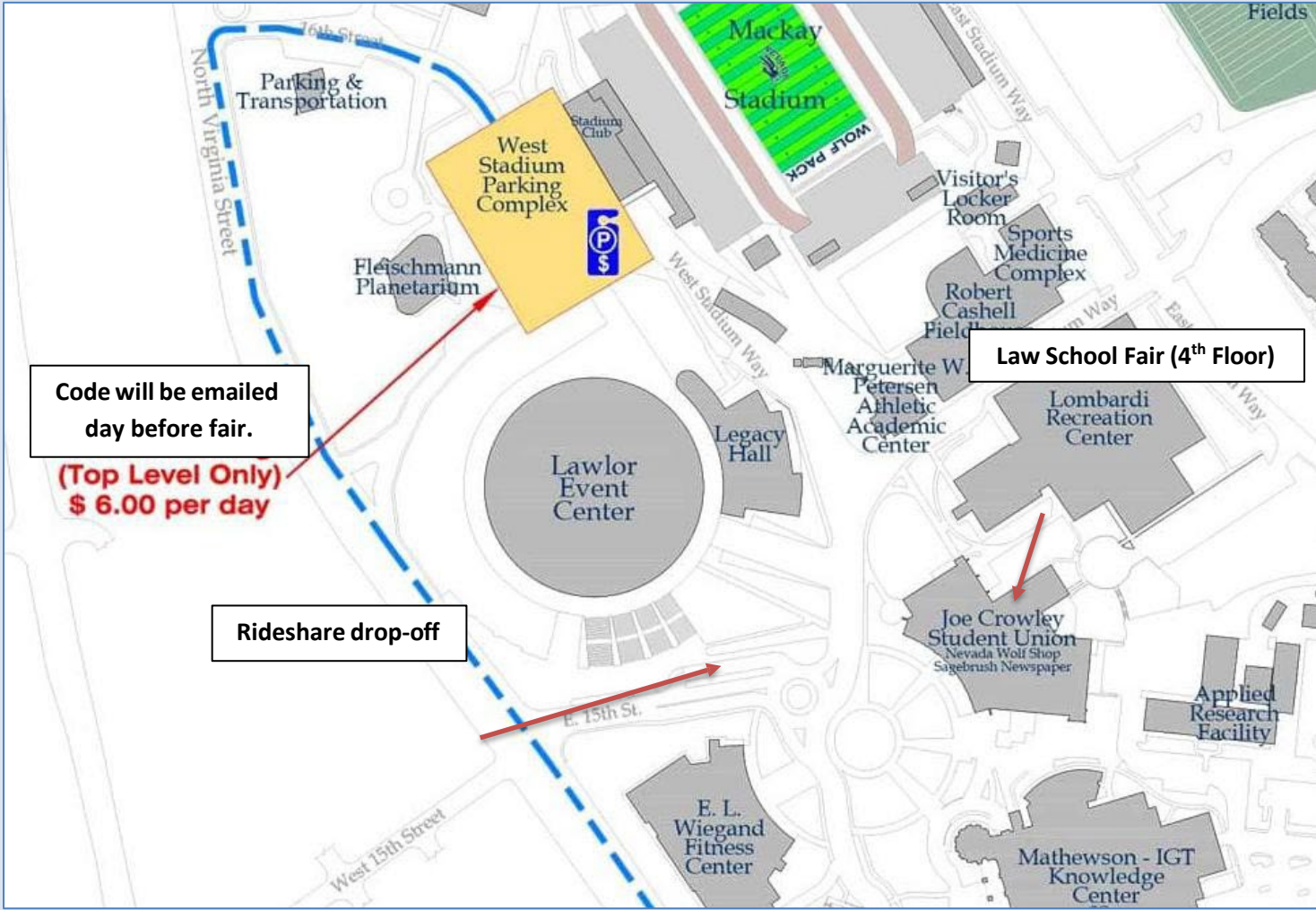

HOTEL

There are many hotels and resorts in Reno. Please keep in mind that hotels/resorts with casinos do allow smoking on the casino gaming floor. The following are a few closer suggestions:

Gaming Hotels: [The Silver Legacy](#), [Eldorado](#), and [Circus Circus](#) are about 1 mile from campus (these three are all physically connected to each other). [Grand Sierra Resort](#) is about 4 miles from campus and 1 mile from the airport. Each of these options have multiple restaurants and activities on site.

Non-gaming/smoking hotels: [Whitney Peak Hotel](#) is about 1 mile from campus. [Renaissance Reno Downtown](#) and [Courtyard by Marriott Reno Downtown/Riverfront](#) are about 1.5 miles from campus. [Hyatt Place](#) and [Aloft](#) are both adjacent to the airport.
