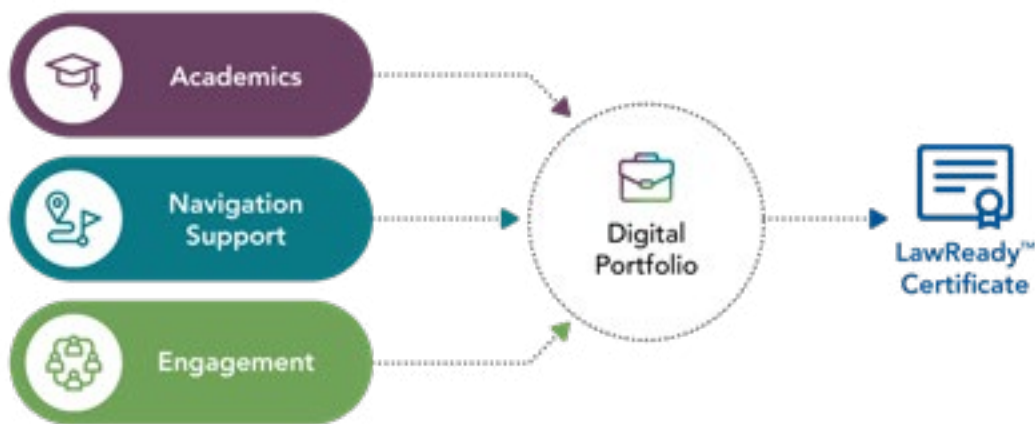


# Advantages of LawReady
