THE LSAT® — MEASURING THE SKILLS YOU NEED TO SUCCEED

The Law School Admission Test (LSAT) is the premier test for law school admission, measuring the skills that are essential to success in law school. The test is a fair, reliable, and scientifically valid exam that was created to expand access to legal education for all and is an integral part of the overall admission process in the United States, Canada, and a growing number of other countries.

It is the only test accepted by all ABA-approved law schools.

WHY THE LSAT?

Reading comprehension, reasoning, and writing are [essential skills](#) you will need to be successful in law school and as a lawyer. Pursuing a legal education is a serious commitment of time and resources, and so preparing for the LSAT is an important part of the admission process. Taking the LSAT will provide you and the law schools to which you apply with a fair assessment of your capabilities and potential for success while introducing you to the skills you will continue to develop while in law school.

LSAT FORMAT

The LSAT consists of three different types of multiple-choice questions and an unscored writing section called “LSAT Writing.” This unscored writing portion of the LSAT is completed online using secure proctoring software that is installed on your own computer.

Multiple-choice questions are divided into the following sections:

- Reading comprehension (measures the ability to read and understand complex texts with accuracy and insight)
- Analytical reasoning (measures the ability to understand a structure of rule-based relationships and to gather reasonable inferences from it)
- Logical reasoning (measures the ability to analyze and evaluate the reasoning and arguments of others)

Some versions of the LSAT may also include an unscored section that is used to pretest new questions that may be used on future tests.

LSAC PRELAW UNDERGRADUATE SCHOLARS (PLUS) PROGRAMS

LSAC's summer PLUS programs are open to everyone and specifically aimed at groups who are underrepresented in the legal profession. The programs are designed for students in the first two years of college. The PLUS programs immerse participants in the law school experience and introduce them to the skills important for law school success. Program participants will have the opportunity to take courses in legal skills, writing, legal research, and advocacy, and will be exposed to various career opportunities in the legal profession. CREDENTIAL ASSEMBLY SERVICESM

LSAC's Credential Assembly Service (CAS) simplifies your law school application process. It streamlines law school admission by allowing all your transcripts and recommendations to be sent only once to LSAC. There, your application documents are summarized and combined with LSAT scores and writing samples, and the resulting law school report is sent to all law schools to which you apply. The schools' applications are also available at [LSAC.org](https://lsac.org).

Once created, your CAS account remains active for five years and includes the following:

- Transcript summarization (as well as authentication and evaluation of academic records for internationally educated JD applicants, if applicable)
- Creation of your law school report (Note: You will need to purchase a law school report for each law school to which you're applying.)
- Letter(s) of recommendation processing
- Electronic application processing for all ABA-approved law schools and some non-ABA-approved schools

SCORE PREVIEW

LSAC offers a score preview option for first-time test takers who wish to see their LSAT score before deciding whether to keep it as part of their LSAC transcript and have it reported to law schools. Score Preview costs \$45 for those who sign up prior to the first day of testing for a given test administration, or \$75 for those who sign up during a specified period after their given test administration. First-time test takers who have an approved LSAT fee waiver can sign up for [Score Preview](#) free of charge.

FEE WAIVERS FOR THE LSAT AND CREDENTIAL ASSEMBLY SERVICE (CAS)

Our fee waiver program is available for those who cannot afford to pay for the LSAT and CAS. This program is part of our mission to reduce barriers for determined law school applicants. More information about the [fee waiver application process](#) can be found on LSAC.org.
